<u>Overture</u>

I know this is likely an incredibly unpopular opinion, especially at this time of year in our organization, but I really don't care much for competitions. I always have, to be honest, in part because it was never a part of my musical life growing up. All the teachers I had on both piano and cello into my junior year of high school hadn't even heard of MTNA, and while I did Solo/Ensemble, it still wasn't my favorite musical activity.

To their credit, competitions such as Solo/Ensemble and CHC and all the way up to the International Chopin Competition, etc., have many benefits. Competitions give us something to strive for in the monotony of practice. They encourage us to work for a goal, often one that will require us to stretch. They earn us comments from teachers and adjudicators other than our usual weekly mentor (who students may tend to tune out week after week). If nothing else, competitions are another performance opportunity in front of a new audience.

However, I also count two big negatives: First, competitions encourage students to measure themselves against each other in an often unhealthy manner-something we most certainly want to avoid, especially among younger teenagers. Second, and relatedly, we can often fall into the trap as teachers of encouraging the mindset that the goal of music is to play in the next recital, the next competition, and put so much emphasis on doing well at them that we miss the true point of learning music.

In my humble opinion the goal of music study is not (just) to be good at music, and it most certainly isn't to be better than someone else (an attitude which we, and competitions, can all too easily foster). Competitions are inherently geared towards awarding "the best," often represented solely by some abstract number

on a scoresheet, but this is a one-way street of perfection instead of the (arguably healthier and more wholistic, if not idealistic) view of music as something done for its inherent joy, and for the communication of that joy between a performer and an audience. Frankly, that is something not easily measured on a judge's scorecard, and requires significantly more time and deliberate energy to encourage than simply enrolling a student in the next competition to perform in.

"525,600 minutes... How do you measure a year? ... How about love!"

How are we teaching our students to measure their success as musicians? How do we measure it ourselves and model that? Something to ponder.

Scholarship Dinner

Thank you to everyone who helped, donated and brought people to our Scholarship Event on January 12th! It would not have been possible without you!

The community businesses that contributed were: Pacific Food Importers, Paolo's Italian Restaurant, San Gennaro Foods, Kent East Hill Nursery, Trader Joe's Kent, Covington Safeway, Covington Fred Meyer and Covington Costco.

We had about 45 people pay plus 10 more in entertainers (some entertainers actually won Silent Auction items!)

Bonnie Birch and Gino Lucchetti were fantastic entertainment during the dinner and silent auction and the Comedy Court Improv provided some great laughs!!! It sure seemed like everyone enjoyed the evening.

We had about \$150 in donations and the silent auction brought in \$781.00 and attendance brought in \$670.00 for a total of \$1,601.00.

Due to a connection I have at the Covington Air Stream, I was able to procure a \$500.00 donation to the Scholarship Fund. Since it was during the Scholarship Event and I had solicited the donation for the event, all of this amount was added into the event total. The grand total is \$2101.00.

So, the bottom line is after expenses we put \$1401.00 into the Scholarship Fund. (The Comedy Court Improv waived their fee for us since it was a fundraiser). This is amazing since attendance and teachers participating were half of last year and brought in \$665 less also.

Overall, it was a great success and I am excited we will to be able to award students scholarships from our chapter!

I have been happy to serve as Scholarship Chair, however, this is my third year and someone needs to step up now for next year. I am happy to help and provide as much input (I have all the forms ready for you) as possible. Please think about it!

It is that time of year! Please discuss with any of your High School seniors about applying for the Gibson Music Scholarship Award. The information is in the Yearbook on pages 24 and 25. However please keep the following changes in mind since they were inadvertently left out.

Gibson Music Scholarship

<u>The Gibson Music Scholarship Award</u> was established through a generous gift of music scores from the estate of former member Leaine Gibson, who passed in 2010.

It will be given annually to a high school senior/s who intends to pursue music as a major or minor at the college level. It is open only to students of SKCMTA members.

Students will need to submit an essay as described on the entry form. The essay should be double spaced in 12 point font, not to exceed three pages.

Candidates will be asked to give an oral presentation to a panel of judges .Students should present their case as to why they deserve this award. Should the student not be able to attend, a video presentation will be acceptable.

Students are encouraged to be as creative as possible. It should be emphasized that this is not a music competition, and is not based on performance. However, if a short instrumental demonstration is necessary to illustrate a point, it will be allowed at the judges' discretion.

First, second and third place awards will be given at the discretion of the panel. Monetary award will be carefully adjusted according to the funds raised at the Scholarship Fundraiser and any other donations to the Scholarship Fund and may vary from year to year.

The essay should be mailed to: SKCMTA, <u>25446 163rd PLSE</u>, Covington, WA <u>98042</u> and postmarked by **March 15**, **2019**.

The oral presentations by the students will take place in April at a time announced after all applications are verified.
