Here is a concise Overture to fit everyone's busy December schedule!

I attended Dr. Oksana Ejokina's pedagogy class during the month of November, as did many others. It was wonderful! Many thanks for her preparation and willingness to share her knowledge with us. I wanted to share with you a few of the points she made on student practicing (which can be easily assimilated to our own practicing). We had much discussion, several students to observe (including our own very brave selves) and handouts for each session. I love teaching piano and practicing for the intellectual growth I gain, as well as for creative outlet. This class helped clarify some of these things for me. A few brief points follow:

Practice should be efficient, effective, engaged and enjoyable

Efficient: thoughtful, not mindless repetition; begin at various points of the piece; target problem areas; practice on a schedule

Effective: Have a targeted goal in mind before beginning; be specific about the problem areas that need to be addressed; decide which practicing approach would work best for each section; practice musicality and phrasing as well as technique

Engaged: Effective and efficient practicing only occurs when we LISTEN to what we play; make a plan, take ownership for practicing time; be creative

Enjoyment comes from progress!

WSMTA State Honors Recitalist Competition (from WSMTA website):

Student type/Age: Regular/MusicLink students – under 19 years of age by June 30 of MAP event year Performance Requirements:

- A student must perform two solo pieces in the Chapter Music Artistry Program
- Piano and vocal soloists must perform both pieces from memory
- Winners of the Piano Competition shall not be named until the above requirements are confirmed
- Memory is optional for organists, brass and woodwind soloists, and piano ensembles (WSMTA recommends memorization of one piece for soloists)
- Memory is not recommended for open instrumentation ensemble category
- All music must meet the repertoire guidelines listed above for each respective category

Winner Requirements (for performance at WSMTA Conference)

- WSMTA State Recital performers must perform the piece selected at the State Recital Competition
- The performance must fit into five minutes, time monitors will stop it by clapping
- Cuts are allowed
- Performers are limited to a single piece or individual movements of suites, sonatas or other groupings by the same composer that can be performed as musical units
